

I am hoping you can assist me with this one. David called me about this drawing request because he advised that the 12" worktop we quoted here is for an electric range and therefore will not work with the gas range Next Step Design specified. In addition to the two (2) documents we shared with David, attached is the original spec document we received from Next Step where they specifically asked for the EV12-SEFAAB.

This project is a Cordish project and we have been guided by Next Step Design that we are to use Endurance products whenever possible for the Vulcan spec. David advised that the 12" worktop cannot be a stand-alone and needs to be

secured to the range but the one Next Step requested will not work.
